Dear Mme. Lavoie:

I am responding to a letter dated September 29, 2022, from Patrick Gatien, former Board Chair, requesting approval for the Conseil scolaire francophone Board of Education to underspend its targeted Indigenous Education funding amount for the 2021/22 school year. As this is targeted funding under Section 106.4 of the *School Act*, Boards of Education must request permission from the Minister of Education and Child Care to underspend their target on an annual basis. As Deputy Minister of Education and Child Care, I am pleased to respond on the Minister's behalf.

Pursuant to Section 106.4(2) of the *School Act*, approval is granted for the Board to underspend its 2021/22 school year Indigenous Education target in an amount up to \$45,344. This variation of direction is granted on the condition that these funds will be brought forward and added to the 2022/23 school year Indigenous Education targeted amount to be expended on Indigenous Education programs. I encourage you to discuss your Indigenous Education targeted funding plans with the District Indigenous Education Council or equivalent, including the Nations and Métis Chartered communities whom you serve, to ensure respectful and meaningful engagement with Indigenous Peoples on the use of these funds.

Appendix to this letter contains statistics about your school district's Indigenous student outcomes. I hope we will see you build upon these achievements and strive for strong academic results for all your students in the current and subsequent school years.

## Appendix – SD93 (Conseil scolaire francophone) Indigenous Student Achievements

In 2021/22 on the Grade 4 Literacy assessment, 79% of Indigenous students were "On Track" or "Extending" expectations on the revised FSA compared to 80% of Non-Indigenous students in SD93.

In 2021/22 on the Grade 4 Numeracy assessment, 67% of Indigenous students were "On Track" or "Extending" expectations on the revised FSA compared to 74% of Non-Indigenous students in SD93.

In 2021/22 on the Grade 7 Literacy assessment, 85% of Indigenous students were "On Track" or "Extending" expectations on the revised FSA compared to 82% of Non-Indigenous students in SD93.

In 2021/22 on the Grade 7 Numeracy assessment, 58% of Indigenous students were "On Track" or "Extending" expectations on the revised FSA compared to 75% of Non-Indigenous students in SD93.

Six-year completion rate for Indigenous students has increased from 94.5% in 2017/18 to 100.0% in 2021/22.

Six-year completion rate for Non-Indigenous students have increased from 98.9% in 2017/18 to 100.0% in 2021/22.

Of 17 Indigenous graduates from SD93 in 2016/17, 8 (47%) immediately transitioned to B.C. public post-secondary institutions, and 4 years after grad, 11 (65%) had transitioned into post-secondary.

Of 141 Non-Indigenous graduates from SD93 in 2016/17, 79 (56%) immediately transitioned to B.C. public post-secondary institutions, and 4 years after grad, 105 (74%) had transitioned into post-secondary.

There is no Indigenous non-graduate from SD93 in 2016/17.

Of 156 Non-Indigenous non-graduates from SD93 in 2016/17, 1 (1%) immediately transitioned to B.C. public post-secondary institutions, and 4 years after grad, 1 (1%) had transitioned into post-secondary.
