Dear Madame Mathewson,

Thank you for your email. I can assure you that the CSF will evaluate all the needs for école Anne-Hébert for 2015-16. A new format is in place this year to allocate the available funds. What has been announced is not all what will be received for 2015-16. It is the core of the allocation and the process continues to allocate more funds for the specific needs of each communities. Madame Asselin is aware of the process. As the CSF superintendent said;

"As indicated to all principals at the round table of April 9-10, and as mentioned by M.Morin, schools received only the base allocation for the year 2015-16. This base amount was established according to the recommendations of representatives of the principals and then presented to all, including Ms. Asselin for consultation. It represents the heart of the allocation for the coming year. However more allocations will be added in the coming days. Among others, we will add allocations for specialized services (education fund), additional staffing in special education, an allocation for students R and Q, an allocation or additional funding for the school's success plan. Ms. Asselin is informed of the process. I'm sure she can tell you more about it."

Education funds are limited and the new format will allow us to respond to the specific needs of each different communities. The final allocation process will take a few more weeks. The specific needs for école Anne-Hébert will be analyzed carefully to respond to them.
